According to the United Nations in November 2001, more than 1 billion people around the world live without clean drinking water, and due to preventable water-related diseases approximately 10,000 to 20,000 children die. In the case of drinking water mentioned above, the world community finances projects to develop water-saving technologies, new technologies that filter non-drinkable water at a lower cost and with better quality, and real support for installation in places with water shortages, gives Another example of this is the drying up of the Aral Sea, which has been an urgent environmental problem in our country for several decades, and in order to solve the environmental problems in its basin, the UN General Assembly declared the Aral region as a region of ecological innovations and technologies. On May 18, 2021, the General Assembly adopted a resolution at the 75th plenary session of the Assembly, and 60 countries co-sponsored this resolution. announced his support. The General Assembly calls on all interested parties to conduct joint interdisciplinary research, develop and implement environmentally friendly technologies, promote inclusive and environmentally sustainable economic growth and use of energy and water-saving technologies. Also in the document, the President of Uzbekistan It is noted that the establishment of the Aral Bay International Innovation Center and the establishment of the Commonwealth Trust Fund for the Aral Bay region under the auspices of the UN are supported by the UN2. Also, international organizations have a clear direction in terms of ensuring solidarity between countries around the world and preventing armed conflicts. The UN plays a key role in this field. The UN is the largest and most influential international organization established for this purpose. It was established on October 24, 1945, and at that time 51 countries joined it as members, and now 189 countries are members. The UN Charter is one of the first international documents aimed at ensuring peace and security in the world. Because it reinforces the following as the goals of the UN:

- > to save the future generation from the disaster of war
- > to create an environment where justice and respect become important principles of the first degree
- > to help improve social welfare and living conditions under greater freedom
- > show tolerance and live together as good neighbors in peace and harmony
- > unification of forces to support international peace and security
- ➤ Development of friendly relations between nations and friendships³.

It can be seen from the above that maintaining peace, not encroaching on the territory of neighboring countries, freeing young generations from war is the duty of every state and nation, and ensuring this is the main function of the UN and other such organizations. But we also see that these organizations and some other countries turn a blind eye to these principles and ignore the hegemonic state's oppression and bombing of a weak state from all sides. Ukraine is an example of
