The construction of a sentence in this style is usually based on the unity of classifying, recording, and deciding parts. That is why relatively long sentences, complex, and compound sentences are often used in Formal business papers. The usual word order is strictly observed in the structure of an Formal sentence. Interrogative and exclamatory sentences are almost never used in the Formal style. Mainly, indicative and imperative sentences are used. The text is written in the first or third person. In the composition of the text of Formal business papers, stable, stereotyped word combinations are widely used. For example, in an order, "... be appointed to the position of ... with a salary of", or in Formal duties, "We inform you" . " is guaranteed." Molded structures such as can be used. [1]

Bernstein examined how language functions in social contexts and analyzed the differences between "authorized" (formal) and "informal" styles. His "code theory" shows how language is differentiated in terms of social class. Bakhtin examined the differences between formal and informal styles through his dialogic theory of language. He examines the role of language in social contexts and the interaction of different styles.
