Such alignment is recognized as a significant contributor to improved student learning outcomes, reinforcing the student-centric ethos of education.

In essence, this systematic literature review demonstrates that teacher-led curriculum development is not a theoretical construct but a transformative force in education. It empowers educators to become architects of learning experiences that are finely tuned to meet the unique needs, interests, and aspirations of students. In doing so, it reaffirms that education is at its most impactful when it is responsive, dynamic, and deeply attuned to the diverse qualities of every learner.

The recognition of teacher-led curriculum development as a catalyst for positive change in education holds profound implications for educational policy, practice, and the broader discourse on 21st-century learning. As education continues to evolve, this approach reminds us that teachers are not just educators but also agents of innovation and transformation, steering the course of education towards greater relevance, inclusivity, and excellence.
