

The National Composition of Personnel in the Organizations of Surkhandarya District in the 20s of the 20th Century

Abstract:

In the 20s of the 20th century, this article discusses the national composition of personnel in state and economic organizations in Surkhandarya district.

Keywords: district, district executive committee, personnel policy, national minority, national composition, representatives of local nationality, representatives of European nationality, employee, leaders.

In the 20s of the 20th century, the Soviet state carried out a policy of forced national-territorial demarcation in the Central Asian republics and formed relations based on inequality in terms of personnel policy in relation to the population of the country. Even remote national regions, including Surkhandarya district, were not spared from this approach. The number of representatives of European nationality in state and economic organizations in the region increased. In order to control this situation, the center has been sending various questionnaires to the places from time to time, and the answers have been received within the specified period and the data has been collected.

In 1927, the State Political Department of the USSR Central Committee sent a secret letter to the executive committee of Surkhandarya district with the registration number 10/02125. In the letter, the Surkhandarya district department of the State Political Department was asked to immediately provide information about the names, year of birth, and account status of the treasurers and those acting as treasurers at the enterprises in the district. In response to this letter, the head of the Surkhandarya district department of the State Political Department, Verkhovsky, and the head of the information department, Godun, wrote the following information about the executive committee of

the Surkhandarya district and the treasurer and those who perform money operations in its departments. information sent to:

Employees of the treasury department of the district executive committee – Koshevoy V.Ye, Baigulov Ye.A; District trade department: Khristoforov A.V.;

G.D. Shilov, Department of Social Security; Engineering Department: Kulikov N.T, Martishin I.I, Korolev A.I, Milachenko F.S, Polyantsev, Metelin N.G, Ivanov, Davidov I.F [1. 66-67]. It is clear from the register that the management of the district treasury was not in the hands of the representatives of the local population.

Based on paragraph 16 of the decision of the meeting of the Presidium of the Surkhandarya District Executive Committee on July 29, 1928, the Surkhandarya District Commission on National Minorities was formed with the following composition:

1. Khabibulin, the deputy chairman of the district executive committee, is the secretary and guide of the national minority commission.

Commission members:

1. Volobuyev – from the Labor Department
2. Abdurashidov – from the Department of Public Education
3. Popovich – from the Matlubot society
4. Kurbanov – from the national minority planning department
5. Maizel – from the collective farm association.

The members of the commission were tasked with developing a work plan within a week and giving instructions to the responsible persons on the ground regarding the work carried out among the national minorities [2. 182].

On January 28, 1928, with the signature of Korostylev, the deputy head of the organizational department of the MIQ of the Uzbekistan SSR, Yakubov, the head of the accounting department, all districts, including Surkhandarya district, were sent to all districts, including Surkhandarya district, with the composition of responsible employees operating at the district and regional level. A registered letter with number 814 was sent asking for information [3.2]. This letter was received by the executive committee of the Surkhandarya district on February 4, 1928, and submitted with number 578. On the basis of this assignment, the following list of leading employees in organizations of Surkhandarya district was formed on February 20, 1928:

The total number of employees of the Surkhandarya district executive committee, i.e., the administrative structure of the district, is 38, of which 16 are representatives of local nationalities, and 22 are Europeans.

The collection of statistical information from higher organizations about employees working in various organizations in the district continued in the following years.

As of August 25, 1928, the national composition of the Surkhandarya District Bureau of Statistics employees:

Total number of employees – 16, russians – 6, ukrainians – 2, latvians – 1, tatars – 1, tajiks – 1, bashkirs – 1, jews – 2, uzbeks – 1, poles – 1 person [5,191].

As of August 25, 1928, the national composition of the employees of the trade organization of the Surkhandarya district: the total number of employees is 3, all of them are Russians [6.192].

As of August 25, 1928, the national staff of the Department of Public Education of Surkhandarya District: total number of employees – 9, uzbeks – 4, russians – 2, tatars – 2, uighurs – 1 [7.193].

As of August 25, 1928, the national composition of the employees of the Finance Department of Surkhandarya district: total number of employees – 21, uzbeks – 1, russians – 13, latvians – 2, tatars – 4, ukrainians – 1 [8.197].

As of August 25, 1928, the national composition of the employees of the Currency Department of Surkhandarya district: the total number of employees – 2 (russians) [9. 198].

As of August 25, 1928, the national composition of the employees of the Local Finance Planning Department of Surkhandarya District: total – 7 people, russians – 6 people, poles – 1 person.

National staff of the Treasury Department: total number of employees – 6, ukrainians –1, russians – 5.

A lot of such information can be given based on archival sources. The policy pursued by the state and its implementation in practical life did not correspond to each other, that is, management bodies made a decision on Uzbekization, and the opposite was done in organizations and enterprises.

In the period from January 1, 1928 to January 1, 1929, the national composition of the employees of the prosecution system of Surkhandarya district:

1. Bobokho'zhayev (prosecutor) – uzbek,
2. Volodin Mikhail Ilyich (assistant prosecutor) – russian,
3. Mushonkov Vasiliy Fyodorovich (secretary) – russian,
4. Golovashenko Yelena Petrovna (case manager) – russian,
5. Myasnikova Valeriya Yakovlevna (typist-secretary) – russian,
6. Yenikeev Mahmud Hasanovich (translator) – tatar,
7. Zaisova Maria Kuz'mina (letter carrier) – russian [10.25].

Total number of employees – 7, uzbeks – 1, tatars – 1, russians – 5. In the state, industrial and economic organizations of Uzbekistan, including Surkhandarya district, for some reason, the first executive officer is a representative of the local nationality, and the rest of the employees are formed almost exclusively of European nationalities. The same process can be seen in the list above. This means that Uzbekization has been treated as a kind of deception.

The national composition of the employees of the Labor Department of Surkhandarya district: the total number of employees – 8, russians – 4, uzbeks – 2, tatars – 2 [11. 207].

As of September 1, 1928, the national composition of the employees of the water management organization of Surkhandarya district: total number of employees – 40, russians - 26, uzbeks – 10, georgians – 1, tatars – 2, armenians – 1 person [12. 209].

The archive documents contain the following information about the national composition of the employees of the Surkhandarya District Court, People's Courts and Control Department as of August 27, 1928:

The total number of employees in the district judicial apparatus is 18, russians – 9, uzbeks – 5, tatars – 3, ukrainians – 1.

National staff of the People's Court of Pattakesar district: total –3 people, tajiks – 1 person, russians – 2 people.

National composition of employees of the People's Labor Court: total number of employees – 2, russians – 2.

National composition of notary office employees: total employees – 2, ossetians – 2 [13,187].

There is a high number of Russians in the national composition of the employees of the district judiciary, Pattakesar District People's Court, People's Labor Court, notary office.

District judges and employees of the control department in Surkhandarya district

National staff of the Pattakesar district control department: total number of employees – 2 (russians).

Sherabad district judge – 1 person (uzbek). Employees of Sherabad district control department – 2 (uzbek).

Employees of Boysun District People's Court – 2 (uzbek). Boysun district control department employees – 2 (1 tajik, 1 uyghur).

Employees of Saryosi District People's Court – 2 (uzbek). Employees of Sariosia district control department – 2 (uzbek).

Denov district people's court employees – 2 (uzbek). Employees of Denov district control department – 1 person (kazakh).

Employees of Zharkurgan district people's court – 2 (uzbek). Employees of the Zharkurgan district control department – 2 (1 uzbek, 1 Tajik) [14,187]. It is clear from the data that in the districts of Surkhandarya district, the national composition of the employees of the judicial branch and the employees of the control departments consisted mainly of representatives of the local nationality.

These situations led to the unemployment of the local population, the fact that the local employees working in that community did not know the language of the Europeans or, on the contrary, the representatives of the European nationality did not master the language of the local population caused various objections.

In general, in 1928, there were 857 employees in 32 organizations in Surkhandarya district, of which 132 were responsible employees, 387 were technical employees, 70 were experts, and 268 were minor service employees, Uzbekization was 33.6%. organized [15. 203].

On March 27, 1929, at the meeting of the Presidium of Surkhandarya district, the issue of distribution of duties of the members of the Presidium was discussed. According to the decision of the meeting, the composition of the district executive committee was approved as follows:

1. The chairman of the district executive committee is Torakhodzhayev
2. The first deputy chairman of the district executive committee is Mavlonberdiyev
3. Federmesser is the second deputy chairman of the district executive committee.

In addition, at this meeting, the heads of state and economic organizations in the district were approved in the following composition:

1. The head of the district water management is Sherbinsky
2. Head of the Department of Public Education of the district – Abdurahmanov
3. Abdurashidov, head of the political education department of the district
4. Head of the district health department – Bojenova
5. Deputy head of the district health department – Laryukhina

6. The head of the district administrative department and the head of the district militia – Berkaliyev
7. Head of the district administrative department and deputy and supervisor of the district police chief – Zoirov
8. Chairman of the district court – Zaripov
9. Deputy chairman of the district court – Zlatin
10. Head of the district finance department – Bobohojayev
11. Deputy head of the district finance department – Smirnov
12. Head of the Okrug Land Department – Norqabilov
13. Maizel, deputy head of the district land department
14. The head of the social security department of the district is Turopov
15. Head of the district trade department – Romanov
16. Head of the District Labor Department – Volobuyev
17. The head of the district worker-peasant supervision – Rahimov
18. Chebotaryov, deputy head of district worker-peasant supervision
19. Head of the State Political Department – Gelman
20. Head of the district military committee – Borodin.

The secretariat of the executive committee of Surkhandarya district was approved in the composition of Torakhodzhayev, Mavlonberdiyev, Shokirov, Federmesser, and Zakirov [16.38].

In the above list, there are 23 managers of Surkhandarya district, 12 of them are Europeans, and 8 are representatives of local nationalities.

At the meeting, the work plan of the executive committee of Surkhandarya district for May-September 1929 was also approved, in which, based on the May plan, the state apparatus was cleaned, and the June plan included the Uzbekization commission of the state apparatus, its work and the state apparatus. Measures for Uzbekization, discussion of the state of work carried out by the district organizational department among the national minority and activities related to the issue of the national minority and revitalization of work in this regard, the situation of immigrants, measures in this area, work to fight against administrative tyranny It is planned to review the ongoing work on the situation.

So, it is clear from the above information that in most of the organizations in the district, the national structure of the leaders and employees consisted mainly of Europeans. It can be seen that the powers and influence of non-local nationals are high in the activities of organizations in the district.
